Secure, Compliant AI Chat Solution for Legal Professionals

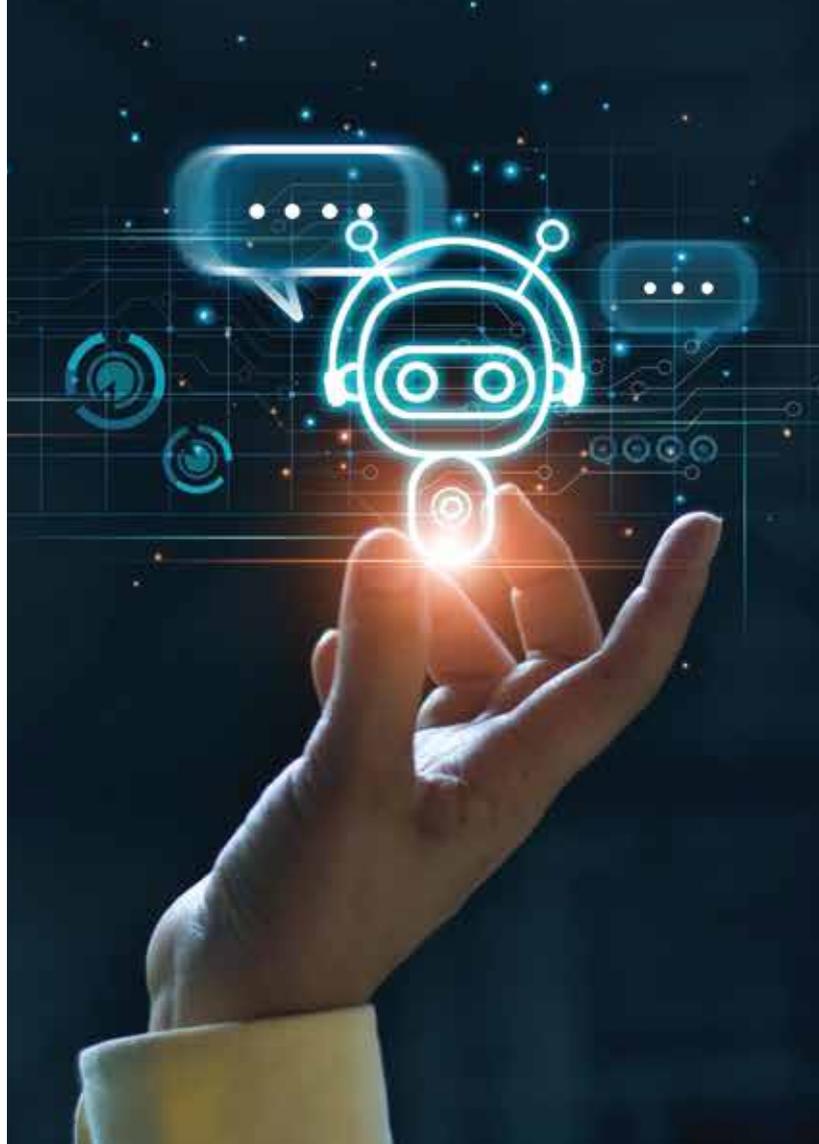

THE CHALLENGE

- › **Prevent use or exposure of sensitive information** in AI chats;
- › **Ensure AI usage** follows company security and compliance standards;
- › **Gain visibility into frequently searched topics** and **user needs**;
- › Avoid **AI silos** and **optimize resource use**;
- › **Build an AI-ready** culture for future initiatives.

GOALS

A leading U.S. based, global law firm needed a secure AI chat solution that aligned with strict security and compliance policies. The firm wanted to prevent sensitive data exposure, ensure AI usage complied with internal guidelines, and gain insights into user needs and search trends. The challenge was not only implementing AI but doing so in a way that combined security, compliance, and strategic intelligence.

SOLUTION

Noesis developed a secure, internal "Chat GPT" platform with a custom-built user interface and dashboard, fully aligned with the firm's policies.

Controlled AI Chat Interface

- › AI chat built on Azure OpenAI (GPT-4o or latest) with strict user policies to prevent sensitive data use;
- › Integrated Azure AI Search for relevant, contextual responses.

Insights Dashboard

- › Admin dashboard showing top searched topics and trending questions, with no user identification;
- › Provides actionable insights to inform future AI development and identify emerging organizational needs.

Custom AI Responses Aligned with Policy

- › AI answers tailored to reflect firm's tone, language, and compliance needs.

User and Admin Experience

- › OutSystems-based chat interface for ease of use and policy enforcement;
- › Admin tools for monitoring AI usage patterns and enforcing governance.



Technical Foundation

Built on Azure OpenAI (GPT-4o or latest), Azure AI Search (hybrid vector + keyword search), Azure Document Intelligence for structured data extraction from PDFs, and Azure Blob Storage for secure document management. OutSystems was used to build a compliant, user-friendly interface and admin dashboard.
